Tournament Headquarters is Juniper Park, (8th and Franklin). Please check in at this location for your first match. Matches will also be played at other locations in Bend.

All matches will be best 2 out of 3 sets, regular scoring with a match breaker for the 3rd set.

Participants may enter in one singles and one doubles and one mixed doubles event.

Consolation matches will be scheduled in singles and doubles ó weather permitting and court availability.

USTA rules will govern play.

The tournament director has the right to reclassify participants if self-placement seems unfair. In doubles events, the total ratings are combined. The difference between partners ratings can be no greater than 1 point. Junior players may participate only in Open or 4.0 events. Note that there is a sanctioned Junior Challenger tournament coinciding with this event for ages 14 and under.
